# Catalog Page 13 Background Checks and Drug Testing

## **Medical Assisting:**

Prior to commencing the externship courses, students may be required to provide results of any of the following:

- Proof of current immunization
- Current physical examination performed by an MD, DO or ARNP
- Proof of personal health insurance
- Clear background check
- A negative urinary drug screen indicating a 10-panel drug screen
- Proof of immunity via documentation of immunization or titers for the following:
  - Hepatitis B series
  - MMR (Measles, Mumps and Rubella)
  - VZV (Varicella) vaccine
  - Negative PPD skin test within the last 6 months (2-step PPD or single step PPD as part of an annual series) or a negative chest x-ray
- A tetanus (Td) booster within the last ten years
- BLS certification

# Attendance Policy for Student Receiving VA Educational Benefits

Special accommodations can be made for military personnel who are called to active duty or reserve training. Service members should see the Director of Education prior to the first date the student will be absent. A copy of military orders must be provided. Upon approval, the Director of Education will grant an extension of time based on the days of required military service and for necessary travel time to and from military duty.

The College will not take any of the following actions when a service member receives an order for a period of service (i.e., active duty, inactive duty training, or state service):

- Assigning the member a failing grade,
- Reducing the member's grade point average,
- Characterizing any member's absence(s) as unexcused, or
- Assessing a financial penalty on a member because of a withdraw or leave of absence due to receiving orders for service.



The College will take the following actions when a member withdraws or takes a leave of absence from a course(s) due to receiving orders for a period of service:

- Refunding all tuition and fees paid for the academic term to the appropriate party,
- Assigning a grade of incomplete (or equivalent) for the course(s) during the term, and
- Providing the opportunity to complete the term after the period of service.

Compliance with 38 USC §3679 (E): Allowing Veterans to Attend or Participate in Courses Pending VA Payment

In accordance with Title 38 US Code 3679(e), Southern Technical College adopts the following additional provisions for any students using U.S. Department of Veterans Affairs (VA) Post-9/11 G.I. Bill® (Ch. 33) or Vocational Rehabilitation & Employment (Ch. 31) benefits, while payment to the institution is pending from VA. The College will not:

- Prevent the student's enrollment;
- Assess a late penalty fee to the student;
- Require the student to secure alternative or additional funding;
- Deny the student access to any resources (access to classes, libraries, or other institutional facilities) available to other students who have satisfied their tuition and fee bills to the institution.

However, to qualify for this provision, such students may be required to:

- Produce the VA Certificate of Eligibility (COE) by the first day of class;
- Provide a written request to be certified;
- Provide additional information needed to properly certify the enrollment as described in other institutional policies.

Diagnostic Medical Sonography Program Academic Progression Requirements

Students in the DMS program must maintain a cumulative GPA of 2.75 at the end of their first term of enrollment and a cumulative GPA of 2.75 at the end of their second term of enrollment as well as each term thereafter.



• Students will take the ARDMS Sonographic Principles and Instrumentation (SPI) Examination within 4 weeks of passing SON125 Principles of Ultrasound Instrumentation and Acoustic Physics. If first attempt is unsuccessful, the student then has a 60-day waiting period per ARDMS, to study and retake the SPI immediately following the 60-day waiting period. If the 2nd attempt is unsuccessful, the student will be dropped from the DMS program. Students may apply to re-enter the DMS program based on program availability and passed SPI exam.

**Program Goals:** To prepare competent entry-level sonographers in the cognitive (knowledge), psychomotor (skills), and affective (behavior) learning domains for the Abdominal Sonography- Extended and Obstetrics and Gynecology Sonography concentrations.

# Catalog Page 61 Course Descriptions

## **SON100 Foundations of Sonography**

4.0 credit hours

This course introduces the field of Diagnostic Medical Sonography and the role of the sonographer in the healthcare industry. In this course students are provided with an overview of related medical terminology, an understanding of medical law and ethics, and general patient care practices, infection control, emergency procedures, blood-borne pathogens, HIV-AIDS, HIPAA, first aid, and CPR. Students also learn ergonomically correct scanning techniques and develop an understanding of the importance of personal fitness, support tools and devices, equipment adjustments, and patient positioning. Prerequisite(s): BSC111 and PHY202.

## **SON102 Applied Sonography**

4.0 credit hours

Presents cross-sectional anatomy, and anatomical relationships of organs. This course also introduces students to the sonographic identification of structures in the thoracic, abdominal, and pelvic cavities. Prerequisite(s): SON100 and SON125.

# SON105 Gross Anatomy 4.0 credit hours

This course introduces students to the necessary protocols and procedures of the ultrasound laboratory, including scanning criteria and documentation of images, in preparation for physician review. Presents knowledge of relational anatomy physiology, pathophysiology sonographic appearance, and the associated vasculature structures. Prerequisite(s): SON100 and SON102.

## **Programmatic Entry Requirements**

## **Wonderlic Entrance Exam**

- The second attempt (first re-take) may be taken after a minimum of 2 hours of tutoring has been completed.
- The third attempt (second re-take) may be taken after an additional 4 hours of tutoring has been completed.
- The fourth attempt (third re-take) may be taken after 3 months have passed since the third attempt.



• The fifth attempt (fourth re-take) may be taken after 12 months have passed since the fourth attempt.

## **Wonderlic SLE Entrance Exam**

- The second attempt (first re-take) may be taken after a minimum of a 24-hour waiting period.
- Additional time to complete a section may be granted if the student has disclosed a documented disability.
- A student who does not achieve the minimum score requirements may re-apply for admission into the program after 3 months and must follow the outlined initial applicant admissions and testing procedures.

**Educational Objectives:** Perform administrative and certain clinical duties under the direction of a physician. Administrative duties may include scheduling appointments, maintaining medical records, billing, and coding information for insurance purposes. Clinical duties may include taking and recording vital signs and medical histories, preparing patients for examination, and drawing blood as directed by physician.

College Policies Catalog Page 39 Safety in Private Spaces Act

In accordance with the Safety in Private Spaces Act, Florida Statute 553.865, a student who willfully enters a restroom designated for the opposite sex on the premise of the educational institution, and refuses to depart when asked by any administrative personnel, faculty member, security personnel, or law enforcement personnel, may result in disciplinary action up to and including suspension or dismissal from the College.

In the event a student believes that the institution has failed to meet the minimum requirements for restrooms and changing facilities under Sections 553.865(4) and (5), F.S. he/she has the right to file a complaint with the Attorney General.

#### **BUS103 Introduction to Business "O"**

6.0 credit hours

This course introduces the functional areas and environments of business administration, including a study of the role of financial accounting and reporting, production and operations, marketing, management, and human resource management in organizations. An overview of legal, economic, ethical, and social/cultural aspects of business in domestic and global markets is also presented.

#### **COC100 Computer Concepts "O"**

4.5 credit hours

This course introduces the student to computer terminology and concepts. This course includes a history of computers, computer components, and an introduction to common operating systems. In addition, the course includes a hands-on introduction to the Windows operating system and word processing, spreadsheet, database and presentation graphics applications programs. Lab included.

## **MAT105 College Mathematics "O"**

6.0 credit hours

This course provides a study of algebra, right triangle trigonometry, coordinate systems, and numerical computations.

## **SON125** Principle Physics of Ultrasound Instrumentation and Acoustic Physics

6.0 credit hours

In depth presentation of concepts related to acoustic physics, Doppler, ultrasound principles, and the operation of ultrasound instrumentation. Topics include ultrasound, tissue interaction, waveforms, transmission, artifacts, imaging modes and transducer technology, as well as quality assurance methods. Prerequisite(s): PHY202 and MAC110.

#### **SON210** Transabdominopelvic Sonography

4.0 credit hours

Presents the sonographic and Doppler appearance, both normal and abnormal, of the abdominal organs, male pelvis, peritoneal, and retroperitoneal structures. Recognition of disease processes and correlation of findings to patient history and physical, differential diagnosis and laboratory findings will be emphasized. Prerequisite(s): SON212 and SON215.

## **SON212 Gynecologic Sonography**

4.0 credit hours

Presents the sonographic anatomy, pathology, physiology, and pathophysiology of the gravid and non-gravid female pelvis. Introduction to embryology, fetal development, pre-menarchal, menarchal, and postmenopausal female reproductive system with an emphasis on the correlation of abnormal findings to patients' medical history, physical examination(s), differential diagnosis, and laboratory findings. Prerequisite(s): SON102 and SON215.

#### **SON218** Embryonic and Fetal Sonography

4.0 credit hours

Presents the sonographic appearance, of both normal and abnormal, fetal and embryonic anatomic structures throughout gestation. Correlation of abnormal findings with maternal history, physical and laboratory findings will be emphasized. Presents the sonographic anatomy, pathology, physiology, and pathophysiology of the gravid. Recognize and identify embryology, fetal development, pre-menarchal, menarchal, and postmenopausal female reproductive system with an



emphasis on the correlation of abnormal findings to the patients' medical history, physical examinations, differential diagnosis and laboratory findings. Prerequisite(s): SON212 and SON215.

## **SON272 Externship Foundations**

3.0 credit hours

In this course, students will be introduced to the appropriate use of oral and written communications and providing appropriate patient care. Students will follow standard policies and procedures for infection control in the health care environment. Students will be observing/performing diagnostic sonographic images under direct supervision. Students will apply and demonstrate knowledge of anatomy, through interaction with clinical instructor and/or ultrasound equipment while practicing ergonomically correct scanning techniques. Prerequisite(s): SON105, SON216 and SON212.

## **SON285 Sonography Externship I**

13.0 credit hours

This course provides an opportunity to apply theory and training acquired in the classroom and laboratory in a clinical setting. Under direct supervision, the student will perform sonographic examinations of the abdomen, superficial structures, obstetrical, gynecological, vascular and the non-cardiac chest by using both transabdominal/endocavitary transducers and Doppler display modes. All the externships occur in a hospital or outpatient clinical setting. Prerequisite(s): Completion of all core courses.

## **SON286 Sonography Externship II**

12.0 credit hours

This course is a continuation of Sonography Externship I, providing the opportunity to apply theory and training acquired in the classroom and laboratory settings to the performance of sonographic examinations in the clinical setting. Students will perform sonographic examinations of the abdomen, superficial structures, the gravid and non-gravid pelvis, fetal and embryonic structures, and the non-cardiac chest using both transabdominal and endocavitary transducers and Doppler display modes. Prerequisite(s): SON285.

## **DROP/ADD PERIOD**

The first week of a twelve (12) week quarter or payment period, ending on Sunday of the first week, is drop/add period for all students. The average student to faculty ratio for didactic courses is 24:1. The average student to faculty ratio for lab courses is 18:1. All admissions/enrollment activities and student services are provided at the main campus for students attending training at the satellite location; therefore, this site has minimal administrative staff with limited administrative responsibilities. Personal computers and printers are available for student use. The Orlando Satellite Location (Welding Classes) is located at 2400 Sand Lake Road, Suite 600, Orlando, FL 32809. The telephone number for this satellite location is (407) 438-6000.

## ORLANDO SATELLITE LOCATION (HVAC AND ELECTRICAL TRADE CLASSES)

The Orlando main campus has a satellite location for HVAC and electrical trade classes in Orlando, Florida. This facility includes multi-purpose classrooms, academic and administrative office space. The trades labs provide settings where students can learn electrical, air conditioning, and heating. The average student to faculty ratio for didactic courses is 24:1. The average student to faculty ratio for lab courses is 18:1.
